Reporting **Schedule for** newly admitted B. Tech. candidates through **JoSAA/CSAB**-**2022** counselling process for the Academic Year **2022-23**

The candidates who have been provisionally allotted a seat in the B. Tech. programmes of IIIT Sonepat through JoSAA/CSAB-2022 counselling process for current Academic Year 2022-23 are required to report ONLINE during **04**th **-09**th **November 2022** by following the process as explained below:

- (1) The candidates who are required to pay Balance Institute Fee, if applicable as per Annexure-B1 & B2, must pay the same through SBI Collect link provided by the Institute in this notification. The link will be active from 10.00 am on 04.11.2022 until 05.00 pm on 09.11.2022.
- (2) Thereafter, the candidates are required to fill the Google Form (link will be available on the Institute website before 04.11.2022) for online reporting wherein the payment receipt of Balance Institute Fee, if applicable, and also the relevant documents as per Annexure-A are to be submitted. The link for Google Form will also be activated for this purpose from 10.00 am on 04.11.2022 and remain active till 5.00 pm on 09.11.2022.
- (3) The candidates are mandatorily required to include the duly filled in and signed undertaking as per **Annexure-D** regarding genuineness and validity of the documents as part of **Annexure-A**.
- (4) The provisional Roll No. will be issued to those candidates only who have completed all the above three steps.
- (5) The admission will be provisional till the documents are physically verified at the Institute on the dates to be notified on Institute website in due course of time.
- (6) The candidates who do not report after payment of Balance Institute Fee, if applicable as per Annexures- B1 & B2, during online reporting as per above schedule will lose their allotted seats for which only they will be responsible. It is responsibility of the candidate to complete all the admission formalities in the finally allotted institute.
- (7) The physical reporting and allotment of hostel will be made on November 13, 2022 after their arrival.

- (8) The orientation programme for 1St semester of B. Tech. programmes will be on November 14, 2022 and the classes commence from November 15, 2022 in offline mode. The schedule & time table for orientation programme & classes will be available on the Institute website in due course of time.
- (9) The Institute fee refund rules, as mentioned in Annexure-B2, shall be applicable if any candidate withdraws his/her admission.
- (10) The candidates are required to visit the Institute website (www.iiitsonepat.ac.in) regularly for latest updates.




Mode of Payment of Institute Balance Fee
