- The candidate is required to pay the Balanced Institute's Fee, if applicable as per Annexure B, must pay through NEFT/RTGS/Net Banking/UPI made before 14.08.2023. The payment proof along with the documents as mentioned in Annexure-A are required to be submitted through E-mail on admissionsonepatiiit@gmail.com.
- The physical reporting and allotment of hostel will be made on August 22, 2023 after their arrival.
- 3. The orientation program for 1st Semester will be on August 24, 2023 (Tentative) and the classes commence from August 25, 2023 (Tentative) in offline mode only. The schedule & time table for orientation program & Classes will be available on the Institute website in due course of time.
- The candidates are required to produce medical fitness certificate on prescribed pro-forma available on the portal. The medical certificate must be certified by Registered Medical Practitioner (RMP).
- The candidates who passed their 10+2 examination from foreign country are also required to produce HIV -ve report. The HIV test must be carried out on arrival of the candidates in India.
- The candidates are required to visit the Institute Website (www.iiitsonepat.ac.in) regularly for latest updates.
